

We can work with you on a one off party celebration or on a regular basis as necessary. Our drinks are flexible, we can make a customised cocktail/drinks menu for your event or if you just want a standard bar service - we are there!

Based in South Wales, we travel across the South West region for all types of parties and events, both indoor and outdoors. We aim to provide a mobile bar service that your guests will enjoy and talk about fondly beyond the event.

Our Bars



Service

We offer a variety of Services depending on your requirements.

Please see the packages below, these are a guide for you. We really do want your bar to be personalised to you therefore welcome a discussion on your exact requirements to give a confirmed costing.

Cash Bar

Suitable for all size events. All guests pay for their own drinks as and when required. We can customise the bar to offer lower or higher end drinks these can include cocktails if required. We do not use 'cheap' alcohol, we serve premium brands only.

Drink Flights

These can start from £3 per head for one drink. These flights contain a set number of drinks. The drinks can be a set drink or mix of beer, wine, spirits and cocktails. The drinks are decided before the event. i.e. £30 a head would consist of 4 spirits and mixers plus a cocktail. The set drink can be customised to what you would like.

Distinction Tokens

We can issue these on the day. These can be given to guests to use at chosen times. This can be a really good way to get your guests into the party spirit!!! The purchase of these can be used towards the minimal spend (see pricing) payment on the day. The tokens can be used for specific drinks or for all drinks, we can decide this prior to the day! We love creating unique tokens for the different celebrations.

Open Bar

We can offer an Open Bar the cost for the bar is worked out on the volume of guests attending. Please contact us for a quote, it will be calculated on the length of time and number of guests attending.



All of our options provide the same level of service, this service includes:

- A fully licensed bar with the personal license holder onsite (Event Manager)
- The Event alcohol license
- Staff that are professional and friendly with your guests
- Public Liability up to £10million
- Fully insured vehicles
- Additional pop up bar if required
- A customised bar to meet your requirements
- Glass or plastic glassware (additional charge for glass)
- Cash and Card payment facilities



Prices

Option A (50 plus guests)

Bar Hire fee £250 (with £1000 minimum spend). Booking fee to be paid to confirm the date £150. Prior to the day we can discuss what type of drinks you would like us to offer. We ask for the minimum amount of £1000 to be paid to us prior to the day. During the day we charge the attendees for the drinks, should we exceed takings in excess of £1000 we will return the full £1000. Should we not take the minimum amount of £1000 we will deduct the amount taken from the £1000 and keep the remainder as payment. The minimum spends of £1000 can be covered throughout the entire event.

Option B (50 plus guests)

Bar Hire Fee - £250. No minimum bar spends. Booking fee to be paid to confirm the date £250 This payment covers the cost of the bar and has no minimum spend. Guests are free to purchase the drinks as they like.

Option C

In addition to Option A and B. Open Bar - We can offer an Open Bar – the price of the bar will be calculated on the number of guests and the types of drinks offered. This can be worked as an addition to the other packages but the money for the open bar will not be returned/refunded. The price of an open bar is calculated by number of drinks and types of drink offered. Champagne is more expensive than beer!

SMALLER EVENTS - 50 guests or less for 3 hours or less

Bar Hire Fee - From £150. No minimum bar spends. Booking fee to be paid to confirm the date. This payment covers the cost of the bar and has no minimum spend. Guests are free to purchase the drinks as they like.

Prices are correct as at 1st January 2021. We reserve the right to change our prices at our discretion. All prices above include VAT.



Terms and Conditions

These terms and conditions form part of a legally binding contract between 'The Gin Tin Bar and Bars' and the Client. Please note Bars of Distinction is a trading name of 'The Gin Tin Bar'. These terms cover all bars owned and operated by The Gin Tin Bar.

Definitions: The following definitions will apply for these Terms and Condition. From here with the term 'The Gin Tin Bar' term will be used to refer to Helen Jones (owner) as the supplier of drinks services. The 'Client' will refer to the individual communications with The Gin Tin Bar and agreeing the terms via email/booking form. The Email/Booking form will be taken as consent and agreement of these terms. If the items in these terms and conditions are not met we reserve the right to either withdraw our services or make an additional charge to cover our reasonable costs or losses in revenue.

Supply of beverages:

'The Gin Tin Bar' shall be a provider of beverages at the event, the type of beverages will be confirmed upon booking. Information regarding any additional beverage supplier on the day will be shared with 'The Gin Tin Bar' by the client prior to the booking being confirmed. To note all Hygiene certificates and licences are under 'The Gin Tin Bar' name.

Bar opening times:

Bar opening times will be subject to agreement with the client/venue and approval by the relevant authorities.



Booking & Payment

A deposit is payable to confirm the booking for bar services, the amount of £250 for option A. A deposit of £250 is payable to confirm the booking of Option B as stated in Bars of Distinction Pricing Packages. FULL PAYMENT FOR SMALLER EVENTS.

The booking can only be confirmed by receipt of the deposit payment. The payment should be made by BACS to H L Jones Sort code 522163 Account No. 12763357

All remaining payments must be received not less than 28 days prior to the event. The deposit is a non-refundable payment for our services at your event. In the unlikely event of the venue and/or the event being refused an alcohol license the deposit less any costs incurred in the alcohol license application process will be refunded. In all other circumstances our acceptance of a payment confirmed in an email will constitute a legally binding contract between 'The Gin Tin Bar' and the client(s) recipient of the email.

Should the booking include an order for venue decor and/or personalised accessories, payment for these must be received sufficiently in advance, and not less than 28 days before the event, to enable any production or manufacturing process to be completed prior to the event. Any further payments due must be received as cleared funds not less than 28 days prior to the event.

Our fees are based on the number of guests, and the services being offered. Should there be a change to the numbers attending, either more or less, it is a condition of the booking that you inform us. In the case of a free or prepaid bar, should more people attend than have been paid for, adults or children, we will give you the opportunity to pay for the additional guests. Such payment must be made immediately. In the event that we cannot locate you, or you refuse to pay we reserve the right to close the bar and remove all our goods and equipment with immediate effect.



'The Gin Tin Bar' will:

- a) Be the provider of beverages at the event.
- b) On behalf of, and at no cost to, the client, obtain any alcohol license required for the event subject to there being no reason for any required license being refused by the Licensing Authority. Bar opening times will be subject to approval by the relevant authorities.
- c) Supply all equipment, staff and drinks. The Licensing Act 2003 All of our bars work under The Licensing Act 2003. Our staff are instructed to operate within these rules.

Please note the following:

- 1) No alcohol will be sold to anyone under the age of 18, or who appears to be so and cannot prove otherwise. If your event includes guests around the age of 18, please ask them to bring ID.
- 2) It is an offence to sell or supply or supply alcohol to anyone under the age of 18. If we suspect that anyone is doing so, service from that person will be withdrawn. If we see anyone we know to be underage drinking alcohol that has been purchased from us, we confiscate the drink or ask you to do so.
- 3) We will not serve anyone who is excessively drunk, or who is abusive or threatening to staff or other customers or guests.

Although 'The Gin Tin Bar' may apply for the license, we would ask the event organiser to be responsible for guests behaviour. Any violence or abuse towards our staff will not be tolerated. In extreme cases we reserve the right to stop serving altogether.

Payment for drinks

All drinks are paid for as sold on the night, with the exception of prepaid drinks packages or prepaid free bars. We do not offer credit to our customers neither will we run a tab type bar unless monies have been paid prior to the event or an agreement has been drawn up and will be confirmed prior to the event via email. Where Tokens are being used all tokens must be paid for in advance.



Access to venue

The client shall ensure sufficient time is available to access the venue prior to the start of the event to unload and prepare equipment and stock. The Client shall also ensure sufficient time between the closing of the bar and having to vacate the venue to enable all goods and equipment to be dismantled, removed and loaded into waiting vehicles.

Vehicle parking

A secure parking spot for 'The Gin Tin Bar' vehicles should be made available next to the venue access point to ensure availability of additional stock and to facilitate easy loading and unloading.

Electric power supply

The client shall ensure a 13amp power supply at or near to the bar location.

Glassware

Due to many of our events being held outside our drinks are served in plastic containers. Should the venue allow glass we can source this if necessary. When Glassware is used, we will try to use a third-party company. we will liaise between client and third-party company to ensure delivery and collection are briefed and prepared correctly in the interests of all parties. Clients are welcome to go direct to source the glassware.

Pop Up Bar

Where the Pop-Up Bar is being used at the event, the terms and conditions of 'The Gin Tin Bar' will also apply to the Pop-Up Bar. The specifics of the event will be confirmed via email between 'The Gin Tin Bar'/Bars of Distinction and the client this is due to the personalisation of the bar.



Disclaimer

"The Gin Tin Bar' does not accept any liability for any failure to provide our services due to an 'Act of God', i.e. circumstances beyond our control, (including flooding, fire, severe traffic congestion, car accidents or any foul weather conditions). A full refund of the deposit will be given in such event. We hold a vast selection of drinks. However, if one drink selection is favoured, we may occasionally run out. If you are aware that your guests require an extensive amount of one drink type, we will attempt to increase stock levels to accommodate your requirements.

Complaints

We treat all complaints about our service, either in advance, during or after the event seriously. If you are not happy with the service whilst the party is happening, the best thing to do is speak with the staff on site and see if the problem can be rectified. We aim to make your event as enjoyable and stress free as possible, please let us know if there are any issues.

Insurance

"The Gin Tin Bar' vehicles are fully insured. 'The Gin Tin Bar also has public liability insurance cover for all events.
